

AN ORDINANCE EXTENDING THE CITY LIMITS OF THE CITY OF HAHIRA,
GEORGIA.

BE IT ORDAINED by the Mayor and Council of the City of Hahira and it is hereby ordained by the authority of same, and pursuant to, in accordance with, and by the authority granted to municipalities by the Georgia General Assembly pursuant to Georgia Law 1962, page 119, as amended, the following described lands, being contiguous to the City of Hahira, are hereby annexed to and incorporated in the corporate limits of the City of Hahira, Georgia, to wit:

All that tract or parcel of land situate, lying and being in Land Lot 50 of the 12th Land District of Lowndes County, Georgia, and being all of that certain 8.5744 acres of land more particularly described according to a plat or map of survey entitled "Survey for Mrs. Helen R. Hensley" made by William H. Branch, Jr., Surveyor, dated April 10, 1989, as follows: Commence at a point on the easterly margin of the right of way of Hagan Bridge Road (County Road #33) (60 foot right of way) where the existing corporate limits of the City of Hahira intersect the same, and run thence North $01^{\circ} 47' 57''$ East 45.30 feet along the easterly margin of the right of way of the aforesaid Hagan Bridge Road to a point and property of Quintin T. Lawson described in a deed recorded in Deed Book 119, page 470, Lowndes County deed records; thence departing the right of way of Hagan Bridge Road North $88^{\circ} 38' 15''$ East a distance of 654.37 feet to a point; thence run South $00^{\circ} 21' 12''$ West a distance of 676.52 feet to a point; thence run North $89^{\circ} 06' 55''$ West a distance of 452.70 feet to a point intersecting the existing city limits of the City of Hahira (existing city limits immediately prior to May 4, 1989) and thence run North $18^{\circ} 05' 11''$ West along the existing city limits to the POINT OF BEGINNING. Reference is specifically made to the aforesaid plat or map of survey for all purposes in aid of description.

And the same is hereby zoned and classified R-1 Zoning Classification. The official zoning map of the City of Hahira is also amended and modified in accordance with the provisions of this ordinance.


The aforesaid property is annexed with the specific stipulation that no sewer service is available to the annexed property at the time of annexation.


