

AN ORDINANCE EXTENDING THE CITY LIMITS OF THE CITY OF HAHIRA,

GEORGIA.

BE IT ORDAINED by the Mayor and Council of the City of Hahira and it is hereby ordained by the authority of same, and pursuant to, in accordance with, and by the authority granted to municipalities by the Georgia General Assembly pursuant to Georgia Law 1962, page 119, as amended, the following described lands, being

contiguous to the City of Hahira, are hereby annexed to and incorporated in the corporate limits of the City of Hahira, Georgia, to

wit:

All that tract or parcel of land situated, lying and being

located in Land Lot 95 of the 12th Land District of Lowndes County, Georgia and being further described as follows: As a point of

reference only begin at the northeast Right-of-Way margin inter-

section of Union Road (40' R/W) and W. Stanfill Street (35' R/W);

thence proceed along the eastern R/W margin of Union Road along

a curve having a radius of 952.00', an arc of 418.66', a chord

bearing of N02°47'38"W and a chord distance of 415.30' to a point;

thence continuing along said R/W margin proceed N09°48'17"E a

distance of 468.05' to a point; thence leaving said R/W margin

proceed S87°47'25"E a distance of 824.47' to a point; thence

proceed S01°05'39"W a distance of 839.45' to a point on the

northern R/W margin of W. Stanfill Street; thence proceed along

said R/W margin N88°54'21"W a distance of 422.04' to a point;

thence continuing along said R/W margin proceed along a curve


having a radius of 3728.14', an arc of 250.08', a chord bearing

of 589.10'21"W and a chord distance of 250.03' to a point; thence continuing along said R/W margin proceed S87.15'03"W a distance of 195.54' to a point and the POINT OF BEGINNING. Said tract contains 24.6741 acres.

And the same is hereby zoned and classified R-6 Zoning Classification. The official Zoning Map of the City of Ahlira is also amended and modified in accordance with the provisions of this ordinance.
