Event Description: In an effort to support local businesses and bring our community together, the City of Hahira is offering an open-air, community-based Farmers Market. The Farmers Market will provide local growers an outlet to showcase and market goods, publicize the importance of locally grown products, and allow citizens of Hahira and surrounding areas the opportunity to buy healthy, locally grown goods.

Dates:

- May 18 and 25
- June 1, 8, 15, 22
- July 6, 13, 20, 27
- August 3, 10, 17, 24

Vendors: Vendors shall be local farmers and gardeners. Applications will be approved for the Farmers Market based on quality and fit for the market, giving precedence to local growers first. Vendors are expected to:

- Report to the “Welcome Station” for check-in beginning at 8:30 AM
- Maintain a clean area during event and clean up prior to leaving
- Provide your own tents, tables, chairs, etc.
- Remove all vehicles from the event area by 9:30 AM
- Set up on time and stay for the full duration of the market

Refunds: There are NO REFUNDS of any kind, including no refunds made for inclement weather or other acts of God over which the event organizers have no control, and the risk of loss from such an event shall be borne by the vendor.

Additional Information:

- Vendors may request a specific spot, but no locations are guaranteed.
- There is no guarantee that any vendor will be an exclusive seller of any product. For certain products only a limited number of vendors will be allowed.
- Do not set up early without getting approval from the event organizer first.
- All vendors will be responsible for collecting and reporting Georgia State Sales Tax (8%).
- Any home baked goods or home canned jellies including honey, shall be labeled with all ingredients as well as the name, address, and phone number of the seller.
