UTILITY SERVICES AGREEMENT:

All garbage is collected at curbside. Collection days are Wednesday-Friday for residential pickup. Garbage containers should be placed at curbside the night before collection day.

Utility bills are mailed on or about the 1st of each month. **All payments are due by the 15th of the month.** Payments may be submitted in person at City Hall, left in the drop box (Red Fire Hydrant in the City Hall parking lot), online at www.hahiraga.gov (click I'd like to...), or mailed to City of Hahira, 102 S. Church St., Hahira, GA 31632. **NOTE: we no longer accept payments made over the telephone effective 1/1/2016!**

Any unpaid bills incur a **15% late penalty on the 16th of each month.** All bills not paid in full by the 25th of each month will be **disconnected at noon on the 25th of each month.** Before service is restored, a reconnection fee is required. A **reconnection fee of \$25.00** is due for restoring service between the hours of 8:00 AM and 3:30 PM. A **reconnection fee of \$75.00** is due for restoring service after 3:30 PM Monday through Friday, on weekends and/or holidays.

Returned checks are grounds for immediate service disconnection, without notice! Restoring service will require a **\$35.00 returned check fee PLUS a reconnection fee** (see above schedule) and **total payment of all charges and late fees** before service can be restored.

Courtesy reminder phone calls **MAY** be placed prior to disconnection of each month. Failure to receive the phone call is NOT grounds for waiver of disconnection fees! It is your responsibility to ensure that City Hall has your current contact number in order to receive notification from the City. **All late payments (after the 15th of each month), disconnection and returned check payments must be paid with Cash, Certified Check, or Money Order.**

Utility Service rates and fees are established by the City Council and are subject to change. If you have questions concerning your bill or service, please contact City Hall at 229-794-2330.

UTILITY PROVIDER INFORMATION

Water, sewer and sanitation service arrangements can be made at City Hall. A \$100.00 deposit is required of residential customers. The City of Hahira may allow for the deposit to be made in two payments if a case of hardship to the customer is proven. Approval would be made by the Public Works Director or the City Manager. The Clerk would be provided with an approval form for the file and the customer would be allowed to pay the balance within 30 days. The City of Hahira will also provide a military discount to active duty personnel. The customer would be required to provide evidence they are currently active duty personnel with proper ID. The Clerk would also document this on the application form.

Hahira offers a City Dump which is located just outside city limits on Union Road. The hours are Wednesday from 1:00 – 6:00 pm, and Saturday from 8:00 am – 5:00 pm (closed for lunch 12:00-1:00). No household garbage, no hazardous materials, no building materials. All cardboard boxes and yard waste must be taken to the dump and will not be picked up by the trash truck.

Pool Owners: You must apply at City Hall for a pool fill. Only one sewer adjustment per year will be approved.
